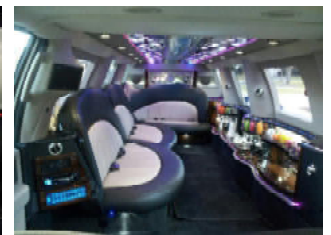
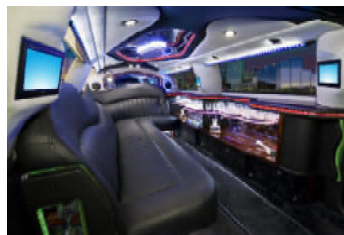

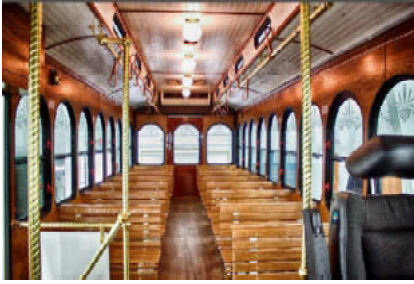
Expedition SUVs

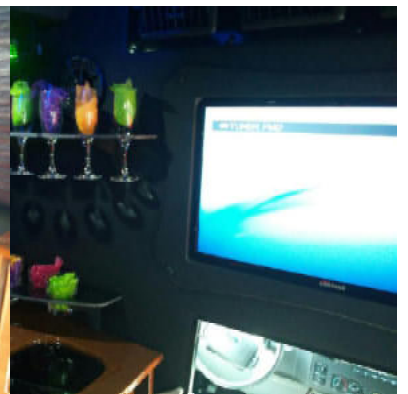
2015 Custom Trolley
